that the aforesaid dog is regularly provided with a tattoo microchip and, in any case, in order, with the obligatory fulfilments according to the Italian law, concerning the compulsory communications and registrations on dogs;
to have read, understood and fully accepted the contents of the Ordinance of the Mayor of the Municipality of Rosolina and the Village Regulations, both available for viewing at the Reception of Rosapineta Camping Village, as well as other relevant laws;
to be aware that animals of an aggressive nature must be leashed and muzzled as described by the Ordinance of the Ministry of Health of 09/09/2003 and that to these breeds the access to the beach is forbidden;
to be aware of the existence, within the Rosapineta Camping Village, of a stretch of beach with allowed entrance of dogs, well indicated by special signs, and of the prohibition of dogs entering other stretches of beach (and animals other than dogs) and that there are no pre-assigned positions on the aforesaid stretch of beach and that therefore, each Guest may position themselves freely, but taking into consideration the obligation to prevent the animal from causing any disturbance or reaching neighbors;
to be aware of the existence, in the aforesaid stretch of beach, of a place for watering and refreshing dogs, where however it is forbidden to use detergents of any kind;
to immediately remove any solid manure using the appropriate hygienic bags and to deposit them in the appropriate waste container and to disperse any liquid excrements by washing them with plenty of sea water;
to be the guardian of the aforementioned dog and to assume full responsibility, with obligation to indemnify Rosapineta Camping Village for any damage or injury, to anyone caused by the dog, both inside the Village and on the beach. The animal cannot be left unattended and free to roam and must be constantly looked after by the handler, who will have to ensure that prolonged barking and excessively lively behavior are avoided, under penalty of removal at the sole discretion of the Management and/or the competent authorities;
<ul> <li>We also report below the obligations and guidelines established by the competent authorities to protect the health of their animals and other users of the beach (Ordinance of the Municipality of Rosolina, n° 08/31.05.2022) subject to any subsequent amendments: <ul> <li>Obligation of valid health booklet.</li> <li>Obligation of regularity of vaccination prophylaxis against the main infectious diseases (distemper, leptospirosis and parvoviruses). Anti-rabies vaccination for dogs coming from abroad.</li> <li>Banned to bring dogs on the beach suffering from cardiovascular diseases.</li> <li>Water reserve and bowl.</li> <li>Paddle and bags for the collection of manure.</li> <li>Obligation of handle the dog on a Leash of maximum length mt. 1.50 and obligation anti-flea collar.</li> <li>Obligation to supervise the animal in order to avoid prolonged barking and excessively lively behavior.</li> <li>Parasol in case of prolonged stationing.</li> <li>Mandatory Stiff or soft shank possession to use in case of risk.</li> </ul> </li></ul>
<ul> <li>Retention of access to the beach for animals in heat and animals of aggressive nature.</li> </ul>

The non-compliance with the requirements and obligations hereby in accordance with these guidelines shall result in the application of penalties, including fines, provided for by law. civil and criminal responsibility for damages to people/things is exclusively of the owner of the dog.
